ITEM NO. 14 REVIEW AND TAKE POSSIBLE ACTION TO AMEND THE RECORDS RETENTION AND DESTRUCTION POLICY TO COMPLY WITH THE BROWN ACT

The current Records Retention and Destruction Policy was adopted by the Board on February 7, 1995. The following is a chronological history of Board action regarding tape recordings of meetings:

- On May 23, 2000 minute recordings were added to the Records Retention and Destruction Policy and stated, "All recordings of Board minutes be destroyed two working days after the minutes are approved by the Board of Directors."
- > On June 6, 2000, the policy was amended by the Board to ". . . discontinue tape recording of the Board of Directors' Meetings."
- > On July 18, 2000, the policy was amended, ". . . to tape record Board Meetings and retain such tapes for 30 days as otherwise described by the Brown Act."
- ➤ On February 2, 2002 the policy was amended to state, "Tape Recordings of the meetings of the Board of Directors shall be destroyed one (1) year after the taping or recording."

Staff is recommending that the Records Retention and Destruction Policy be amended to state, "Tape recordings of the meetings shall be destroyed 30 days after the taping or recording," to comply with the Brown Act.

The Brown Act requires that any tape or film record of an open and public meeting made for whatever purpose by or at the direction of the local agency is subject to the Public Records Act; however, it may be erased or destroyed 30 days after the taping or recording. (Government Code §54953.5(b).) Further, as required by Government Code §60201(d)(3),

the District retains the Minutes of all Board Meetings indefinitely and therefore, there is no need to retain the tape recordings for one year.

COMMUNICATIONS ITEM NO. 16

A. **GENERAL MANAGERS REPORT**

Safety Activities

1. OID went 630 days without a lost time injury accident. On October 25 an employee suffered a groin strain, ending a record spree of no worker injuries. Great job to all employees!!

Administration Activities

- 1. Attended lunch with Congressman Jeff Denham on water issues in our area. SSJID in attendance as well.
- WaterFix and the modeling runs used as the basis of impacts were the discussion topics under examination by the lawyers in Sacramento last week at the State Water Board.
- 3. Water Quality Control Plan (Unimpaired Flow Standard) from the State Water Resources Control Board is still being reviewed for the finer details and impacts.
 - a. Meeting with westside irrigation districts this week who have concerns about the SED plan.
 - b. Meeting with Bureau of Reclamation on WQCP in early November on same.
 - c. Hearing dates Nov. 10th, 29th in Sacramento and Dec. 16th, 19th and 21st in Stockton, Merced and Modesto, respectively.
- 4. Settlement discussions on the Stanislaus River may pick up again in November. Awaiting some guidance from State officials. Could consume lots of time in November and December.
- 5. OE3 labor negotiations continuing.
- 6. Staff met on 2017 Budget development in preparation for Finance Committee.

- 7. Still waiting for City of Oakdale's response on an Action Plan OID sent over.
- 8. Doing another FishBio photo documentary on the rainbow trout concerns in the Stanislaus River.

Legal Activities

- 1. Agee vs OID: OID lost on its motion to recoup its attorney fees.
- 2. OID/SSJID vs the State Water Resources Control Board; this case is over the legal ability of the SWRCB to issue curtailment orders over senior water right holders, as was done in 2015. Court date set for next summer.
- 3. OID/SSJID as intervenors in the CalSPA v. SWRCB regarding the legality of the SWB's use of Emergency Change Petitions issued to the BOR in managing the State's water resources. A trial date is set for Alameda County Court on August 7, 2017.
- 4. OGA/Brichetto/Frobose vs. OID:
 - a. Trial set for January 18th
- 5. OID vs Directors Santos and Altieri.
 - a. The case is moving forward.
- 6. Redistricting Process
 - a. Process to begin after first of the year. Board presentation in February and Hearing in late February with Board adoption in March.
 - b. Regulatory compliance is 180 days preceding the election (May 11th)

Construction Activities

- 1. C&M crews and equipment are currently working on maintenance activities and JSF's completed by Water Dept. staff. C&M staff are preparing sites for capital projects to commence upon dewatering of the system.
- 2. Assisting Water Ops./Eng. Dept. with various tasks and field review of potential projects.
- 3. Conducting Safety Coordinator tasks pertaining to all hands training, Safety Committee meetings and review of weekly tailgate safety meetings. Continuing to conduct the standard construction refresher training with DSO's when they are available. Scheduled a training day for Dec. 14th for ACWA/JPIA instructors to teach three classes to OID staff; Asbestos Cement Pipe Safety, Field Ergonomics & Fall Protection.
- 4. Conducting Contract Administration tasks pertaining to contracts that need to be renewed and work releases that need to be completed with the assistance of Lori.
- 5. Conducting misc. landowner meetings in regards to capital projects and maintenance issues.
- 6. Assisting Engineering Dept. in regards to the Two-Mile Bar Tunnel Project.
- 7. Commenced interviews with candidates for the vacant DSO/C&M & C&M Worker positions.

Water Operations Activities

Engineering

- 1. Continued to process Encroachment and Ag Discharge Agreements along with field inspection during installation of the associated facilities.
- 2. Staff continued to work with landowners requesting deferred conditions of approval agreements, encroachment agreements and easements in accordance to OID's requirements for continued irrigation on recently completed lot line adjustments and parcel split projects.

- 3. ET monitoring stations installed as part of the 2016 ETAW monitoring and measurement program collected data through the end of October. Weather permitting, the Dessert Research Institute stations are scheduled to be removed on or about November 2nd. The Tule ET stations may remain in the field to collect additional data for the full year of the contract period pending permission and an updated contract with the associated landowners.
- **4.** The next monthly ESJGBA and work group meetings are scheduled to be held on November 9th. Discussion of the draft JPA/MOU agreement discussions will continue.
- 5. Staff completed draft mapping of OID's proposed GSA boundaries in the ESJ GW Basin and forwarded to SSJID, Calaveras County Water District and Stanislaus County for review of the line work in adjoining areas. The required GSA hearing, resolution and final filing is requested to be completed for each election being proposed by March 2017 to ensure any potential issues can be resolved prior to the June 2017 deadline.
- **6.** Additional comments on the draft MOU regarding STRGBA GSA formation were discussed at the October 8th meeting. Final review and comments are requested ASAP to allow for an updated draft to be assembled for discussion at the next STRGBA meeting on November 10th.
- 7. A request for data from OID as well as from the STRGBA was rec'd by Stan. Co.'s consultant in support of the County's draft PEIR GW model development. Staff began to compile the data for submittal.
- 8. Staff is working on draft Annexation Agreements for final approval by the board. Little progress to date has been made given the priority of closeout of the irrigation season and the finalization of engineering plans.
- **9.** Emily Sheldon, OID's Associate Engineer, gave birth to a baby girl on October 21st. Mom, family and baby are doing well. Congratulations to Emily. She will be missed over the next several weeks while she gets settled in with the new arrival.
- 10. Pertinent options and factors to consider in the Board of Director Divisions Redistricting Project will be brought back to Board for consideration and staff direction no later than January to ensure completion prior to the next election.
- 11. City staff continued to address a series of questions on the draft City of Oakdale Out of Boundary Service Agreement with OID on behalf of ID 41. Once these questions have been answered the agreement will be provided to the ID 41 membership for approval to proceed.
- **12.**Weekly meetings continued with Condor staff to proceed with the South Main Canal Segment 4 design along with the finalization of the Two Mile Bar Tunnel Project bid documents and cost estimate.
- **13.** Staff continued the surveying, design, cost estimates, landowner meetings and drafting of plans for 2016/17 winter work projects.

Ag Water

- 1. The final round of volumetric water delivery tracking will close on October 31st, Standard QA/QC procedures for review of deliveries in this tracking period continued.
- 2. The public comment period on the Prop. 1 grant funding draft awards list closed on September 14th. The final awards list is anticipated to be posted before the end of the year.
- 3. Interviews to fill a vacant DSO/C&M position started the week of October 24th.
- 4. The second rotation in October and final of the 2016 calendar year started on or about October 17th. Water remained in the system as demand dictated nearly to the end of

October. DSOs made water available as reasonably requested through the last week of October and initiated winterization procedures before starting winter C&M activities in the first week of November.

Water Utilities

- 1. Improvement District No. 41:
 - Pumping Station No. 3 remains out of service due to high turbidity issues.
- 2. Domestic Water Pumping Stations:
 - Monthly Coliform Bacteria samples were taken on Tuesday October 4th. No problems were detected.
 - All Domestic Water Pumping Stations that are in service are operational.
- 3. Domestic Water Systems:
 - > All water systems are operating without restrictions.
 - > Performed quarterly blow-off valve exercising.
 - > Performed Air Relief Valve exercising.
 - > WUD has continued to test all backflow devices in accordance with our Cross Connection Control Policy.
 - Conducted inspections of all well head seals and continuing to replace them as needed.
- 4. On-Call Activities:
 - There are zero calls to report.
- 6. Knights Ferry Pumping Station:
 - The Knights Ferry Pumps are activated. The river pumps are providing water to the treatment plant.
- 7. Irrigation Pumping Stations:
 - All of OID Ag pumps are operational.
 - WUD has been performing weekly routine inspection, servicing and security checks on the irrigation pumping stations. There was nothing unusual or out of the ordinary to report.

REVIEW AND TAKE POSSIBLE ACTION TO REJECT ANY AND ALL CLAIMS FILED BY PARTICIPANTS OF THE ON-FARM WATER CONSERVATION PROGRAM AND TO AUTHORIZE GENERAL COUNSEL AND THE GENERAL MANAGER TO SETTLE ALL PENDING AND FUTURE DAMAGE CLAIMS

Generally speaking, the Tort Claims Act requires the presentation of a claim to a public entity for money or damages as a prerequisite to bringing a lawsuit against it. (Gov. Code, §§ 905, 905.2, 910, 945.4.) The primary function that serves is to apprise the governmental body of the possibility of imminent legal action so that it may investigate and evaluate the claim and, where appropriate, avoid litigation by settling meritorious claims. (City of San Jose v. Superior Court, supra, 12 Cal.3d 447, 455; C.A. Magistretti Co. v. Merced Irrigation Dist. (1972) 27 Cal.App.3d 270, 276; Jenkins v. Contra Costa County (1985) 167 Cal.App.3d 152, 157.)

The claims process commences with the presentation of a claim by the claimant or by a person acting on his behalf. (Gov. Code, § 910; cf. §§ 905, 911.2.). ACWA/JPIA recommends rejecting all claims received. Said notice of rejection narrows the available litigation window from 2-years down to 6-months.

On March 15, 2016 the Board approved the One Year Pilot On-Farm Water Conservation Program. After approval of the Program, 59 contracts were entered into and executed by Program participants.

On April 1, 2016, OGA, Louis Brichetto and Bob Frobose filed a suit against the OID challenging the On Farm Water Conservation Program.

On May 27, 2016 The Superior Court of Stanislaus County issued a preliminary injunction prohibiting OID from continuing with the On-Farm Program until a court trial is concluded.

OID has complied with the court's order and has not performed any actions under the 59 contracts that were executed by participant landowners.

To date, OID has received 5 claims resulting from non-payment on executed contracts under the On-Farm Conservation Program. A copy of those claims are attached and a summary of the claim amounts are provided below.

Excerpts from Government Code:

Section 912.4. (a) The board shall act on a claim in the manner provided in Sections 912.6, 912.7, or 912.8 within 45 days after the claim has been presented. If a claim is amended, the board shall act on the amended claim within 45 days after the amended claim is presented.

- (b) The claimant and the board may extend the period within which the board is required to act on the claim by written agreement made either:
- (1) Before the expiration of the period.
- (2) After the expiration of the period if an action based on the claim has not been commenced and is not yet barred by the period of limitations provided in Section 945.6.
- (c) If the board fails or refuses to act on a claim within the time prescribed by this section, the claim shall be deemed to have been rejected by the board on the last day of the period within which the board was required to act upon the claim. If the period within which the board is required to act is extended by agreement pursuant to this section, the last day of the period within which the board is required to act shall be the last day of the period specified in the agreement.

Section 912.6. (a) In the case of a claim against a local public entity, the board may act on a claim in one of the following ways:

- (1) If the board finds the claim is not a proper charge against the public entity, it shall reject the claim.
- (2) If the board finds the claim is a proper charge against the public entity and is for an amount justly due, it shall allow the claim.
- (3) If the board finds the claim is a proper charge against the public entity but is for an amount greater than is justly due, it shall either reject the claim or allow it in the amount justly due and reject it as to the balance.

- (4) If legal liability of the public entity or the amount justly due is disputed, the board may reject the claim or may compromise the claim.
- (b) In the case of a claim against a local public entity, if the board allows the claim in whole or in part or compromises the claim, it may require the claimant, if the claimant accepts the amount allowed or offered to settle the claim, to accept it in settlement of the entire claim.
- (c) Subject to subdivision (b), the local public entity shall pay the amount allowed on the claim or in compromise of the claim in the same manner as if the claimant had obtained a final judgment against the local public entity for that amount, but the claim may be paid in not exceeding 10 equal annual installments as provided in Section 970.6 only if the claimant agrees in writing to that method of payment and in such case no court order authorizing installment

AGRICULTURAL WATER USER RATES FOR THE WATER YEAR 2017

WHEREAS, California Water Code Section 22280, et seq. provides that the District may levy charges in lieu of assessments; and

WHEREAS, Water Code Section 22283 provides that the District may prescribe reasonable rules to carry out the provisions of the Water Code section 22280, et seq.; and

WHEREAS, said change is exempt from CEQA under Public Resources Code Section 21080(a) (8); and

WHEREAS, on October 21, 2014, the District accepted and approved the increase in agricultural water user rates as identified in Exhibit A as the maximum that could be imposed without being subject to the requirements of Article XIII D(6) of the California Constitution; and

WHEREAS, the District declares the following:

- (1) The revenues derived from these rates do not exceed the funds required to provide subject properties related services.
- (2) The revenues derived from the rates will not be used for any purpose other than that for which the rates are imposed.
- (3) The amount of a rate imposed shall not exceed the proportional cost of the service; and

NOW BE IT RESOLVED AND ORDERED, the District desires to implement Agricultural Water User Rates for the 2017 water year to remain the same as the 2016 water year as follows:

- (1) FIXED CHARGE to be implemented.
- (2) VOLUMETRIC CHARGE to be implemented.
- (3) DROUGHT SURCHARGE will not be implemented.
- (4) Three-percent ANNUAL INFLATION will not be implemented.

BE IT FURTHER RESOLVED, that all charges as identified in this Resolution shall be applicable to each separate parcel, as shown on the District records of Stanislaus County and San Joaquin County Assessor's Parcel Maps.

BE IT FURTHER RESOLVED, that each said <u>fixed</u> charge shall be collected in two equal installments, the first of which is due on December 30, 2016, and the second on June 20, 2017. If payment for the first installment is not received in the District office by 5:00 p.m. payment will be considered delinquent, and penalty charges will be made according to current policy. If payment for the second installment is not received in the District office by 5:00 p.m. payment will be considered delinquent, and penalty charges will be made according to current policy.

BE IT FURTHER RESOLVED that the District shall charge and collect, in accordance with California Water Code sections 26077, the following penalties on <u>fixed</u> charges that become delinquent:

Fixed Charge

Ten percent (10%) on the first installment.

Five percent (5%) on the second installment plus \$5.00 service charge.

BE IT FURTHER RESOLVED that each volumetric billing is due within 30 days of said statement date. Irrigation water deliveries will continue if not paid by the aforementioned due date, and no penalties will be applied. If the current year's volumetric charges are not paid by Friday, December 29, 2017 at 5:00 p.m. at the District office, penalties will be applied. Postmarks will not be accepted.

BE IT FURTHER RESOLVED that the District shall charge and collect, in accordance with California Water Code sections 26077, the following penalties on <u>volumetric</u> charges that become delinquent:

Volumetric Charge Ten percent (10%)

BE IT RESOLVED that said *volumetric* charge will be billed for the following periods:

- Start of the irrigation season through May 31st each year,
- June 1st through July 31st, each year,
- August 1st through the end of the irrigation season each year.

NOW THEREFORE, BE IT FURTHER RESOLVED that parcels of lands with outstanding current year charges as of December 31st each year will not be furnished irrigation water for the subsequent irrigation season until these charges are paid in full.

The Oakdale Irrigation District (OID) will be replacing approximately one thousand three hundred forty (1,340) linear feet of pipeline as part of the Adams Lateral No. 2 Pipeline Project this 2015/2016 construction season. A portion of this project parallels the southern boundary of the parcel noted above. ENCROACHMENT PERMIT ON THE ADAMS LATERAL NO. 2

THIS ENCROACHMENT PERMIT executed this SIXTEENTH day of NOVEMBER, 2016, by and between OAKDALE IRRIGATION DISTRICT, an irrigation district organized and existing under the laws of the State of California, hereinafter referred to as "DISTRICT," and KENNETH C. JOHNSON, JR. AND LAURA C. JOHNSON, TRUSTEES OF THE KENNETH C. JOHNSON, JR. AND LAURA C. JOHNSON 2013 TRUST DATED JULY 9, 2013, hereinafter referred to as "OWNER" sets forth Permits as follows:

WITNESSETH:

WHEREAS, the Board of Directors of the DISTRICT adopted the request for an Encroachment Permit on November 16, 2016, as shown in the Resolution attached hereto as **Exhibit "A."**

WHEREAS, DISTRICT occupies easements and fee-owned lands for its irrigation and drainage facilities, and

WHEREAS, OWNER'S property described in the attached **Exhibit "B"** (the "Subject Property") is subject to all or a portion of said easements, and

WHEREAS, OWNER has title to the Subject Property and wishes to encroach upon the Adams Lateral No. 2 right-of-way with encroachments as follows:

Six-strand barbed wire fencing.

WHEREAS, DISTRICT is willing to permit said encroachments provided the OWNER agrees to the following provisions:

1. <u>Nature of Right Conferred.</u> This Permit is valid only for the purposes specified herein, and neither the Permit, nor use there under shall create an easement, right-of-way, or other interest in real property owned by DISTRICT.

DISTRICT intends hereby to assent only to (a) an encroachment upon an easement or easements held by DISTRICT or (b) to confer a license to OWNER to

encroach upon DISTRICT fee-owned lands, all subject to the terms hereof. Nothing in this Permit constitutes a grant or other disposition of any land or interest in land, which is owned or otherwise occupied by DISTRICT. OWNER acknowledges that the lands upon which the facilities of DISTRICT are located may not be owned by DISTRICT, and further acknowledges that the consent contained in this Permit relates only to the rights of DISTRICT by virtue of an easement or easements upon Subject Property or upon land owned in fee by DISTRICT. It is understood that nothing in this Permit shall be considered as a representation by DISTRICT of the authority to grant any interest in land over, across, or under any property owned or controlled by any person other than DISTRICT and OWNER shall obtain any further grants or consents from all others owning interests in the underlying easement land.

- 2. <u>Assignments, Sublicenses and Termination.</u> The right to use or maintain the encroachments listed above on the subject DISTRICT facility as authorized herein shall be transferrable to OWNER'S successors or assigns, however, OWNER may not, without the prior written consent of DISTRICT, authorize or permit others to utilize any facilities, structures, easements or right-of-way area which are in any way not expressly authorized by this Permit. Should OWNER wish to terminate this permit, written notice shall first be provided to DISTRICT. Upon approval, DISTRICT may request with 30 days written notice, the removal or relocation of all or portions of OWNER'S encroachments and OWNER shall perform the required work at no cost to DISTRICT. Should OWNER'S encroachments not be removed within the specified time, DISTRICT shall remove the encroachments and bill OWNER for all costs incurred.
- 3. Operational Access. DISTRICT shall have the right of necessary ingress to and egress from said strip of land at any and all times for people with tools and/or equipment required for the repair, replacement, maintenance and/or operation of that irrigation canal or pipeline system and appurtenant facilities located within DISTRICT right-of-way. OWNER'S encroachment shall not interfere with DISTRICT's operational use of its irrigation and drainage facilities.
- 4. <u>Indemnity and Release</u>. OWNER shall (i) indemnify and hold harmless and (ii) release DISTRICT, its officers, agents and employees, against and from any and all loss, damage, claims, costs and expenses of whatsoever nature, including court costs and attorney's fees resulting from the exercise of this permit including but not limited to, overflow of water from DISTRICT facilities, property damage, personal injury or, wrongful death from the installation, construction, maintenance, repair, renewal, modification, reconstruction, relocation or removal of the permitted OWNER facilities or any part thereof. OWNER shall promptly repair, at his own cost and under DISTRICT supervision, any damage caused to DISTRICT'S facilities due to work under this permit, to the satisfaction of DISTRICT. Should OWNER neglect to promptly make repairs, DISTRICT may make repairs or have repairs made and OWNER shall pay all costs.
- 5. Plans and Specifications: Construction. All encroachments and structures constructed under this Permit shall be erected by DISTRICT. Should DISTRICT allow OWNER to construct the encroachments and structures, the work shall be done in accordance with plans and specifications and upon locations approved in

advance by DISTRICT as herein provided and shall be erected in such a manner as not to obstruct in any manner the flow of water in the canals, laterals or drain ditches of DISTRICT or to make more expensive or to interfere in any manner whatsoever with the construction, operation and maintenance of any part of the impacted irrigation and/or drainage works by DISTRICT. Any alterations or changes to the approved plans shall be approved by DISTRICT. **Exhibits "C" and "D"** (IF ATTACHED) indicate approved locations and/or plans of herein described encroachments. **Exhibit "E"** (IF ATTACHED) provides the Insurance and Bonding requirements of DISTRICT, which shall be met by OWNER prior to the start of construction.

Should DISTRICT allow OWNER to construct the encroachments and structures, OWNER shall call DISTRICT'S Engineer at 847-0341 a minimum 48 hours prior to planned construction and shall coordinate all construction activities with DISTRICT'S Water Operations Department. Further, routine inspections by DISTRICT of construction activities such as trenching, backfilling, compaction, concreting, etc., are required. OWNER and/or his contractors shall comply with all applicable laws, regulations and guidelines including OSHA, CAL-OSHA, State of California Department of Industrial Safety and Health Orders, Cal-Trans, and California Health and Welfare.

6. Ordinary Maintenance, Repair or Replacement. OWNER shall maintain and repair said encroachments at his sole cost and expense. Should OWNER neglect to promptly make repairs which impair the integrity and/or serviceability of DISTRICT facilities, DISTRICT may make repairs or have repairs made and OWNER shall pay all costs and expenses. Where necessary, and to the extent required to perform ordinary operation, maintenance, and reconstruction functions, DISTRICT may request, upon 30 days notice, the removal or relocation of portions of OWNER'S encroachments and OWNER shall perform the required work at no cost to DISTRICT.

For emergency purposes OWNER will be required to remove encroachments immediately upon request by DISTRICT. If it should be necessary to repair or replace DISTRICT facilities, DISTRICT is not liable for damages or resultant damages to the permitted encroachments within the DISTRICT'S easement. Further, the repair and replacement of OWNER encroachments following DISTRICT maintenance and reconstruction efforts shall be performed by OWNER and at the expense of OWNER.

THIS PERMIT shall be a covenant binding upon both DISTRICT and OWNER.



AGRICULTURAL DISCHARGE PERMIT ON THE MOOTZ LATERAL

THIS AGRICULTURAL DISCHARGE PERMIT executed this SIXTEENTH day of NOVEMBER, 2016 by and between OAKDALE IRRIGATION DISTRICT, an irrigation district organized and existing under the laws of the State of California, hereinafter referred to as "DISTRICT," and COELHO FARMING, LLC, hereinafter referred to as "OWNER" sets forth permits as follows:

WITNESSETH:

WHEREAS, the Board of Directors of the DISTRICT adopted the request for an Agricultural Discharge Permit on November 16, 2016, as shown in the Resolution attached hereto as **Exhibit "A."**

WHEREAS, DISTRICT occupies easements, rights of way and fee-owned lands for its irrigation and drainage facilities, hereinafter referred to as "CONDUITS".

WHEREAS, OWNER'S property described in the attached **Exhibit "B"** (the "Subject Property") is subject to all or a portion of said easements, rights of way and fee-owned lands, and

WHEREAS, OWNER has title to the Subject Property and requests that DISTRICT grant permission to release said Agricultural Discharge as needed, subject to the terms and conditions of this AGRICULTURAL DISCHARGE PERMIT, from one (1) 4" sch. 40 PVC private agricultural filter station backflush pipeline.

WHEREAS, DISTRICT is willing to permit said Agricultural Discharge provided the OWNER agrees to the following provisions:

I. Definitions

- A. "CONDUITS" shall mean the water collection system consisting of canals, laterals, ditches, flumes, pipelines and appurtenant facilities for the transportation, control and collection of irrigation water that DISTRICT owns, maintains and operates.
- B, "Discharge" shall be defined as agricultural and storm drainage from OWNER'S property.
- C. "Emergency Circumstances" shall mean a situation when it is necessary to act to prevent imminent and substantial harm to persons or damage to property.
- D. "Hazardous Materials" shall mean any flammable, explosive or radioactive material; any toxic substance, hazardous waste or substance, as those terms may now, or may in the future, be defined by any applicable federal, state or local agency.

II. Flow

Subject to full compliance with the following conditions and limitations, OWNER may pump and/or allow the Discharge to flow into the MOOTZ LATERAL at a point located in the southeastern quarter of Section 32, Township 2 South, Range 10 East, M.D.B.&M.

- 1. Except as provided in this Permit, OWNER may not release Discharge into any CONDUITS other than the above described District facility.
- OWNER shall reduce or cease said rate of flow upon request of DISTRICT at any time that DISTRICT encounters Emergency Circumstances and perceives a risk that said flow may exceed the capacity of said District Facility.
- 3. The right of DISTRICT to control OWNER Discharge in Emergency Circumstances does not impose a duty of DISTRICT to regulate such flow.
- 4. Construction, installation, reconstruction, modification, and repair of the Discharge lines and appurtenances shall be performed under the supervision of DISTRICT and in accordance with applicable DISTRICT Standards and Specifications, at OWNER's sole expense.

III. Water Quality

OWNER shall not release any Discharge into any CONDUITS that would cause DISTRICT to fail to meet water quality standards that are now or may be imposed upon DISTRICT'S CONDUITS by any federal, state, regional, or local regulatory agency; or would cause DISTRICT to fail to meet water quality standards hereafter established by DISTRICT'S Board of Directors

- and applied on a DISTRICT-wide level, and adopted by DISTRICT Resolution after a public notice and meeting.
- 2. If the Discharge released by OWNER into the CONDUITS causes or threatens to cause significant degradation of the quality of water in the CONDUITS or downstream, the DISTRICT may require that OWNER immediately suspend making any such discharge, and such discharge shall be resumed only after such condition has been resolved to the satisfaction of DISTRICT or interested regulatory agency. Should any court or regulatory agency order, by way of a final nonappealable order, that the release of OWNER Discharge be restricted or be treated before being released into the CONDUITS, DISTRICT shall have the right to unilaterally amend this Permit to require OWNER to conform to such order at OWNER's sole expense.
- OWNER shall not discharge any Hazardous Material into the CONDUITS.
 OWNER shall immediately notify DISTRICT and immediately remediate any
 release or spill of a Hazardous Material into the CONDUITS at OWNER's
 sole expense, to the satisfaction of DISTRICT and any interested regulatory
 agency.
- 4. OWNER shall be responsible for the quality of the Discharge released into the CONDUITS and shall insure that all Discharge so released complies with all applicable federal, state, regional, and local laws, rules and regulations. Any damage to persons, the environment, surface water, or groundwater that results solely from the discharge by OWNER that does not comply with the requirements of this Permit shall be solely the responsibility of OWNER.
- 5. OWNER warrants that said chemical injection shall occur downstream of filtration device and that appropriate backflow prevention has been installed as shown in **Exhibits "C" and "D"** (IF ATTACHED).
- 6. Execution of this DISCHARGE PERMIT shall not release OWNER from being in full compliance with all applicable laws, regulations and guidelines including OSHA, CAL-OSHA, State of California Department of Industrial Safety and Health Orders, Cal-Trans, and California Health and Welfare Codes.
- 7. OWNER shall be a member in good standing of an applicable Water Quality Coalition in accordance with requirements set forth in the Long Term Irrigated Lands Regulatory Program and shall submit to DISTRICT written verification demonstrating such upon request.

IV. Monitoring

 OWNER shall furnish DISTRICT, without cost, copies of any and all analyses or recorded water quality testing of the Discharge to be discharged pursuant to this Permit upon request. 2. DISTRICT shall have the right, but not the obligation, after reasonable prior notice to OWNER, to enter upon the property of OWNER for the purpose of obtaining samples of the Discharge being released to the CONDUITS.

V. Warranties

- 1. DISTRICT does not warrant that DISTRICT owns all the lands upon which the CONDUITS are located in fee title. DISTRICT does not warrant that DISTRICT has the authority to grant access to OWNER across any property not owned in fee title by DISTRICT. DISTRICT shall promptly notify OWNER of any issues regarding property use or access relating to this Permit.
- DISTRICT does not warrant that the alignment and condition of any CONDUITS will not change. DISTRICT, in its sole discretion, may decide to move, pipe, underground, realign or reconstruct any CONDUITS. OWNER shall bear all direct and indirect costs or expenses of relocating OWNER'S outfall and outlet works in such event.

VI. Maintenance and Operations

- DISTRICT may require that OWNER cease any and all discharge into said facility when DISTRICT deems it necessary to perform ordinary maintenance and reconstruction work until such time as DISTRICT informs OWNER that such work is completed.
- 2. Except in Emergency Circumstances, DISTRICT shall provide OWNER advance notice of any ordinary maintenance and reconstruction work that will require OWNER to cease any and all discharge into said facility.
- The maintenance, operation and repair of any facility constructed or owned by OWNER for the purpose of releasing Discharge into the CONDUITS pursuant to this Permit shall be the responsibility of OWNER. OWNER shall provide DISTRICT five (5) days advance notice of any construction or maintenance of such facilities. DISTRICT may require OWNER to repair or replace such facilities if they constitute an unreasonable danger to any person or property or unreasonably interfere with DISTRICT use of the CONDUITS. Failure to maintain such facilities in a safe and useable condition shall be grounds for immediate termination of this Permit and removal of such facilities at OWNER's sole expense. DISTRICT shall in no way be obligated to move, repair, and/or replace such works of OWNER in the event of a realignment, reconstruction, or piping of the CONDUITS.

VII. Use of CONDUITS

OWNER'S rights granted by this Permit are subject and subordinate to all uses and purposes DISTRICT may make of the CONDUITS or of any other facilities or property of DISTRICT. Any use made by OWNER of the CONDUITS pursuant to this Permit shall not limit, impair, hinder, or obstruct any authorized use by DISTRICT of said CONDUITS. OWNER use of the

CONDUITS is subject to all leases, easements, licenses, restrictions and conditions, covenants, encumbrances, liens, and claims of title that may affect the CONDUITS.

- 2. DISTRICT, in Emergency Circumstances, may require OWNER to reduce or terminate said Discharge to a rate established by DISTRICT, if the release of Discharge by OWNER pursuant to this Permit is determined by DISTRICT to substantially interfere with DISTRICT use of the CONDUITS.
- 3. This Permit only creates the ability of OWNER to use the CONDUITS for a limited purpose and under limited conditions. It does not create any equitable interest in the CONDUITS, or an easement, nor does it convey to OWNER any right, title or interest in or to any property or facility of DISTRICT. OWNER shall make no other use of the CONDUITS other than as expressly provided in this Permit.
- 4. Except as already exists, or as herein expressly permitted, OWNER shall not place or permit to be placed on, in, across or through the CONDUITS easements or rights of way, any object or structures, nor do or permit to be done anything which may interfere with the full and exclusive enjoyment by DISTRICT of its CONDUITS, easements and rights of way.
- 5. Upon termination of this Permit, for any cause, DISTRICT may prevent further Discharge from flowing into the CONDUITS either by requiring that OWNER close any positive points of shutoff of OWNER'S or by requiring OWNER to physically remove or seal off OWNER facilities where they enter the CONDUITS and/or the DISTRICT'S easements and rights of way. OWNER shall restore the property of DISTRICT to a condition reasonably acceptable to DISTRICT upon removal of OWNER facilities.

VIII. Defense, Indemnification, Liability and Damages

- 1. OWNER shall defend and indemnify DISTRICT, its Directors, officers, employees and agents, for all costs, damages, penalties and fees of any kind from claims, complaints or causes of action for illness, death, personal injury, property or environmental claims, including attorneys fees incurred in a judicial or administrative proceeding, where such claim, complaint or cause of action arises solely out of the release of OWNER Discharge into the CONDUITS by OWNER. This obligation shall survive the termination of this Permit.
- 2. Should the DISTRICT'S CONDUITS or the natural drainage streams, channels or rivers, or the drains and channels of others, into which the CONDUITS flows, be, for any reason beyond their reasonable control, incapable of handling the agricultural discharge flows produced and generated by OWNER through no fault of DISTRICT, then DISTRICT shall incur no liability to OWNER.

- 3. Should the DISTRICT require cessation of OWNER Discharge due to Emergency Circumstances beyond the control of DISTRICT, then DISTRICT shall incur no liability to OWNER.
- 4. Should it become necessary to reduce or terminate OWNER's discharge into the CONDUITS due to any regulatory, administrative or court action, then DISTRICT shall incur no liability to OWNER.

IX. Termination

- 1. Subject to DISTRICT'S right to suspend release of agricultural discharge under Paragraph 4 of Article III, above, if after thirty (30) days written notice by DISTRICT to OWNER of a release of Discharge into the CONDUITS which is contrary to the terms and conditions identified or referred to in Section III, and if such condition which caused such release has not been substantially corrected by OWNER, then DISTRICT, after a public hearing noticed by agenda with specific prior notice being given to OWNER, shall be free to terminate this Permit. Should DISTRICT terminate this Permit pursuant to this paragraph, OWNER shall continue to defend and indemnify DISTRICT in accordance with Section VIII herein with regard to liability or causes of action resulting from the performance of this Permit.
- 2. For any other breach of this Permit not covered in Sections II and III, DISTRICT and OWNER shall give thirty (30) days written notice to the other of any breach and provide the other with the ability to cure the breach. If such breach is not cured within such thirty (30) day period, the non-breaching party may terminate this Permit.
- 3. Upon termination of this Permit by either party, OWNER shall be responsible for removing all of its facilities that are within the property, easements or rights of way of DISTRICT and used to release Discharge into the CONDUITS. If OWNER does not remove these facilities promptly, then DISTRICT shall remove the facilities and OWNER shall reimburse DISTRICT for all costs incurred.

X. Assignment

1. The right to discharge as authorized herein shall be transferrable to OWNER'S successors or assigns, however, OWNER may not, without the prior written consent of DISTRICT, authorize or permit others to utilize any facilities, structures, easements or right-of-way areas which are in any way not expressly authorized by this Permit. Should OWNER wish to terminate this permit, written notice shall first be provided to DISTRICT. Upon approval, DISTRICT may request with 30 days written notice, the removal or relocation of all or portions of OWNER'S discharge encroachments and OWNER shall perform the required work at no cost to DISTRICT. Should OWNER'S discharge encroachments not be removed within the specified time, DISTRICT shall remove said encroachments and bill OWNER for all costs incurred.

XI. Miscellaneous Provisions

- 1. This Permit fully incorporates the permits and understandings of OWNER with DISTRICT with respect to the subject matter hereof and all prior negotiations, drafts, permits (including the Interim Permit) and other communications between OWNER and DISTRICT are superseded by this Permit. The parties have read and fully understand the terms of this Permit and have had the opportunity to be advised by an attorney with respect to this Permit. No alteration or amendment to this Permit shall be effective unless given in writing and signed by the parties sought to be charged or bound by the alteration or amendment.
- 2. This Permit has been negotiated and executed in the State of California. If there is a lawsuit, OWNER agrees to submit to the jurisdiction of the courts of the County in which this Permit is recorded. This Permit shall be governed by and construed in accordance with the laws of the State of California.
- 3. The words "OWNER" and "DISTRICT" include the successors, assigns, and transferees of each of them. Caption headings in this Permit are for convenience purposes only and are not to be used to interpret or define the provisions of this Permit. This Permit is the product of negotiation of the parties and the rule of Civil Code, Section 1654 regarding uncertainties caused by a party shall not apply. If a court of competent jurisdiction finds any provision of this Permit to be invalid or unenforceable as to any person or circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances and all provisions of the Permit in all other respects shall remain valid and enforceable. It is not necessary for either party to inquire into the powers of the other or of the officers, directors, partners, or agents acting or purporting to act on its behalf.
- 4. The parties shall not be deemed to have waived any rights under this Permit unless such waiver is given in writing and signed by the party being charged with waiver. No delay or omission on the part of the parties in exercising any rights shall operate as a waiver of such right or any other right. A waiver by a party of a provision of the Permit shall not prejudice or constitute a waiver of the party's right otherwise to demand strict compliance with that provision or any other provision of this Permit. No prior waiver by party, nor any course of dealing between the parties, shall constitute a waiver of any of a party's rights or of any of a party's obligations as to any future transactions. Whenever the consent of a party is required under this Permit, the granting of such consent by that party in any instance shall not constitute continuing consent.

THIS PERMIT shall be a covenant binding upon both DISTRICT and OWNER.

ENCROACHMENT PERMIT ON THE MOOTZ LATERAL

THIS ENCROACHMENT PERMIT executed this SIXTEENTH day of NOVEMBER, 2016, by and between OAKDALE IRRIGATION DISTRICT, an irrigation district organized and existing under the laws of the State of California, hereinafter referred to as "DISTRICT," and COELHO FARMING, LLC, hereinafter referred to as "OWNER" sets forth Permits as follows:

WITNESSETH:

WHEREAS, the Board of Directors of the DISTRICT adopted the request for an Encroachment Permit on November 16, 2016, as shown in the Resolution attached hereto as **Exhibit "A."**

WHEREAS, DISTRICT occupies easements and fee-owned lands for its irrigation and drainage facilities, and

WHEREAS, OWNER'S property described in the attached **Exhibit "B"** (the "Subject Property") is subject to all or a portion of said easements, and

WHEREAS, OWNER has title to the Subject Property and wishes to encroach upon the MOOTZ LATERAL right-of-way with encroachments as follows:

1. One (1) 4" sch. 40 PVC private agricultural filter station backflush discharge pipeline

WHEREAS, DISTRICT is willing to permit said encroachments provided the OWNER agrees to the following provisions:

 Nature of Right Conferred. This Permit is valid only for the purposes specified herein, and neither the Permit, nor use there under shall create an easement, right-of-way, or other interest in real property owned by DISTRICT.

DISTRICT intends hereby to assent only to (a) an encroachment upon an easement or easements held by DISTRICT or (b) to confer a license to OWNER to encroach upon DISTRICT fee-owned lands, all subject to the terms hereof. Nothing in this Permit constitutes a grant or other disposition of any land or interest in land, which is owned or otherwise occupied by DISTRICT. OWNER acknowledges that the lands upon which the facilities of DISTRICT are located may not be owned by DISTRICT, and further acknowledges that the consent contained in this Permit relates only to the rights of DISTRICT by virtue of an easement or easements upon Subject Property or upon land owned in fee by DISTRICT. It is understood that nothing in this Permit shall be considered as a representation by DISTRICT of the authority to grant any interest in land over, across, or under any property owned or controlled by any person other than DISTRICT and OWNER shall obtain any further grants or consents from all others owning interests in the underlying easement land.

- 2. Assignments, Sublicenses and Termination. The right to use or maintain the encroachments listed above on the subject DISTRICT facility as authorized herein shall be transferrable to OWNER'S successors or assigns, however, OWNER may not, without the prior written consent of DISTRICT, authorize or permit others to utilize any facilities, structures, easements or right-of-way area which are in any way not expressly authorized by this Permit. Should OWNER wish to terminate this permit, written notice shall first be provided to DISTRICT. Upon approval, DISTRICT may request with 30 days written notice, the removal or relocation of all or portions of OWNER'S encroachments and OWNER shall perform the required work at no cost to DISTRICT. Should OWNER'S encroachments not be removed within the specified time, DISTRICT shall remove the encroachments and bill OWNER for all costs incurred.
- 3. Operational Access. DISTRICT shall have the right of necessary ingress to and egress from said strip of land at any and all times for people with tools and/or equipment required for the repair, replacement, maintenance and/or operation of that irrigation canal or pipeline system and appurtenant facilities located within DISTRICT right-of-way. OWNER's encroachment shall not interfere with DISTRICT's operational use of its irrigation and drainage facilities.
- 4. <u>Indemnity and Release</u>. OWNER shall (i) indemnify and hold harmless and (ii) release DISTRICT, its officers, agents and employees, against and from any and all loss, damage, claims, costs and expenses of whatsoever

nature, including court costs and attorney's fees resulting from the exercise of this permit including but not limited to, overflow of water from DISTRICT facilities, property damage, personal injury or, wrongful death from the installation, construction, maintenance, repair, renewal, modification, reconstruction, relocation or removal of the permitted OWNER facilities or any part thereof. OWNER shall promptly repair, at his own cost and under DISTRICT supervision, any damage caused to DISTRICT'S facilities due to work under this permit, to the satisfaction of DISTRICT. Should OWNER neglect to promptly make repairs, DISTRICT may make repairs or have repairs made and OWNER shall pay all costs.

5. Plans and Specifications: Construction. All encroachments and structures constructed under this Permit shall be erected by DISTRICT. Should DISTRICT allow OWNER to construct the encroachments and structures, the work shall be done in accordance with plans and specifications and upon locations approved in advance by DISTRICT as herein provided and shall be erected in such a manner as not to obstruct in any manner the flow of water in the canals, laterals or drain ditches of DISTRICT or to make more expensive or to interfere in any manner whatsoever with the construction, operation and maintenance of any part of the impacted irrigation and/or drainage works by DISTRICT. Any alterations or changes to the approved plans shall be approved by DISTRICT. Exhibits "C" and "D" (IF ATTACHED) indicate approved locations and/or plans of herein described encroachments. Exhibit "E" (IF ATTACHED) provides the Insurance and Bonding requirements of DISTRICT, which shall be met by OWNER prior to the start of construction.

Should DISTRICT allow OWNER to construct the encroachments and structures, OWNER shall call DISTRICT'S Engineer at 847-0341 a minimum 48 hours prior to planned construction and shall coordinate all construction activities with DISTRICT'S Water Operations Department. Further, routine inspections by DISTRICT of construction activities such as trenching, backfilling, compaction, concreting, etc., are required. OWNER and/or his contractors shall comply with all applicable laws, regulations and guidelines including OSHA, CAL-OSHA, State of California Department of Industrial Safety and Health Orders, Cal-Trans, and California Health and Welfare.

6. Ordinary Maintenance, Repair or Replacement. OWNER shall maintain and repair said encroachments at his sole cost and expense. Should OWNER neglect to promptly make repairs which impair the integrity and/or serviceability of DISTRICT facilities, DISTRICT may make repairs or have repairs made and OWNER shall pay all costs and expenses. Where necessary, and to the extent required to perform ordinary operation, maintenance, and reconstruction functions, DISTRICT may request, upon 30 days notice, the removal or relocation of portions of OWNER'S

encroachments and OWNER shall perform the required work at no cost to DISTRICT.

For emergency purposes OWNER will be required to remove encroachments immediately upon request by DISTRICT. If it should be necessary to repair or replace DISTRICT facilities, DISTRICT is not liable for damages or resultant damages to the permitted encroachments within the DISTRICT'S easement. Further, the repair and replacement of OWNER encroachments following DISTRICT maintenance and reconstruction efforts shall be performed by OWNER and at the expense of OWNER.

THIS PERMIT shall be a covenant binding upon both DISTRICT and OWNER.



BACKGROUND AND/OR HISTORY:

The Oakdale Irrigation District (OID) received a request to review the possibility of quitclaiming and abandoning the Albers Lateral No. 2 within the parcel noted above. Staff has reviewed and determined that the pipeline portion of the Albers Lateral No. 2 within the parcel noted above is operationally unnecessary and that quitclaim and abandonment will not be detrimental to the operations of OID. However, the open ditch upstream of the pipelined portion of the facility will need to continue to be maintained as an OID facility. As part of this project, the landowners have granted OID a perpetual easement for the open ditch portion of the Albers Lateral No. 2 within the limits of APN: 014-043-008. 





 - o \$3 million in life cycle replacements and \$3 million in modernization
- Develop affordable ways to finance improvements
 - o \$168 million of costs to achieve goals by 2030
 - o 67 TAF of Conservation: 50 TAF in water transfers, 17 TAF to SOI

It continues to be our goal to:

- Construct and build-up funds to for the new 5,300' tunnel on the South Main Canal to address high hazard sections due to fall-hazards and creep failure.

SPECIAL BOARD MEETING OF NOVEMBER 16, 2016

GENERAL MANAGER'S REPORT NOVEMBER 16, 2016

Safety Activities

1. OID has gone 23 days without a lost time injury accident.

Administration Activities

- 1. Water Fix testimony continues in Sacramento.
- 2. Water Quality Control Plan (Unimpaired Flow Standard) from the State Water Resources Control Board is still being reviewed for the finer details and impacts.
 - a. Meeting with Bureau of Reclamation on WQCP in next week.
 - b. Hearing dates Nov. 18th, 29th in Sacramento and Dec. 16th, 19th and 20th in Stockton, Merced and Modesto, respectively. A move afoot to get meetings rescheduled into January to avoid the Christmas holidays and impacts to people's lives who had holiday plans.
- 3. Settlement discussions on the Stanislaus River may pick up again in November. Awaiting guidance from State officials. Could consume lots of time in November and December.
- 4. OE3 labor negotiations continuing.
- 5. Still waiting for City of Oakdale's response on an Action Plan OID sent over.

Legal Activities

- 1. Agee vs OID: OID lost on its motion to recoup its attorney fees.
- 2. OID/SSJID vs the State Water Resources Control Board; this case is over the legal ability of the SWRCB to issue curtailment orders over senior water right holders, as was done in 2015. Court date set for next summer.
- 3. OID/SSJID as intervenors in the CalSPA v. SWRCB regarding the legality of the SWB's use of Emergency Change Petitions issued to the BOR in managing the State's water resources. A trial date is set for Alameda County Court on August 7, 2017.
- 4. OGA/Brichetto/Frobose vs. OID:
 - a. Trial set for January 18th
- 5. OID vs Directors Santos and Altieri.
 - a. The case is moving forward.
- 6. Redistricting Process
 - a. Process to begin after first of the year. Board presentation in February and Hearing in late February with Board adoption in March.
 - b. Regulatory compliance is 180 days preceding the election (May 11th)

Construction Activities

- 1. C&M crews and equipment operators have commenced the construction season. Projects are under way as well as maintenance tasks that could not be completed during the water season.
- 2. Assisting Water Ops./Eng. Dept. with various tasks.
- 3. Conducting Safety Coordinator tasks as needed.
- 4. Conducting Contract Administration tasks as needed.
- 5. Interviews for the C&M Worker & DSO/C&M continued until November 7th. Candidates will be selected for the positions and offered positions at the District.
- 6. Two Mile Bar Tunnel Project Received all updated contract documents, technical specifications, Geotechnical Baseline Report and Design Report from Condor. Currently conducting a final document review before going to bid Dec. 1st.

Water Operations Activities

Engineering

- 1. Continued to process Encroachment and Ag Discharge Agreements along with field inspection during installation of the associated facilities.
- 2. Staff continued to work with landowners requesting deferred conditions of approval agreements, encroachment agreements and easements in accordance to OID's requirements for continued irrigation on recently completed lot line adjustments and parcel split projects.
- 3. ET monitoring stations installed as part of the 2016 ETAW monitoring and measurement program collected data through the end of October. The Dessert Research Institute stations were successfully removed on November 2nd and 3rd. The Tule ET stations may remain in the field to collect additional data for the full year of the contract period (+/- May 2016) pending permission and an updated contract with the associated landowners.
- 4. The monthly ESJGBA work group meeting was held on November 9th. Discussion of the draft JPA/MOU agreement discussions continued. The draft GSP BMPs were also presented and discussed.
- 5. Staff completed draft mapping of OID's proposed GSA boundaries in the ESJ GW Basin and forwarded to SSJID, Calaveras County Water District and Stanislaus County for review of the line work in adjoining areas. The required GSA hearing, resolution and final filing is requested to be completed for each election being proposed by March 2017 to ensure any potential issues can be resolved prior to the June 2017 deadline.
- 6. The updated draft MOU regarding STRGBA GSA formation was presented with comments incorporated and discussed at the November 10th meeting. The final draft is anticipated to be brought to each agency's governing board prior to the end of the calendar year for approval.
- 7. A request for data from OID as well as from the STRGBA was rec'd by Stan. Co.'s consultant in support of the County's draft PEIR GW model development. Staff began to compile the data for submittal before the end of November deadline.
- 8. Staff is working on draft Annexation Agreements for final approval by the board. Unfortunately little progress has been made to date given the engineering department is temporarily shorthanded and the high priority of finalization of engineering plans for winter construction projects.
- 9. Pertinent factors and options for the Board of Director Divisions Redistricting Project will be brought back for consideration by the Board and subsequent staff direction no later than January to ensure completion prior to the next general election.
- 10. City staff continued to address a series of questions on the draft City of Oakdale Out of Boundary Service Agreement with OID on behalf of ID 41. Once these questions have been answered the agreement will be provided to the ID 41 membership for approval to proceed.
- 11. Weekly meetings continued with Condor staff to proceed with the South Main Canal Segment 4 design along with the finalization of the Two Mile Bar Tunnel Project bid documents and cost estimate.
- 12. Staff continued the surveying, design, cost estimates, landowner meetings and drafting of plans for 2016/17 winter work projects.

Ag Water

1. The final round of volumetric water delivery tracking closed on October 31st. Standard QA/QC procedures for review of deliveries in this tracking period were completed to allow billing to proceed the first week of November.

- 2. The public comment period on the Prop. 1 grant funding draft awards list closed on September 14th. The final awards list is anticipated to be posted before the end of the year.
- 3. Interviews to fill a vacant DSO/C&M position were completed the week of November 7th. A letter of offer was provided to one of the applicants to fill the currently vacant position.
- 4. OID's preliminary district use numbers for the month of October were 13,704 ac-ft. OID's 10 year average water use in October is just over 10,000 ac-ft. Considering most years in the recent past water was only in the system for first half of the month, this was a pleasant surprise and some positive feedback from the growers was received.

Water Utilities

- 1. Improvement District No. 41:
 - Pumping Station No. 3 remains out of service due to high turbidity issues.
- 2. Domestic Water Pumping Stations:
 - Monthly Coliform Bacteria samples were taken on Tuesday November 1st. No problems were detected.
 - All Domestic Water Pumping Stations that are in service are operational.
 - ID 51 pump station #2 had motor repaired as preventative maintenance.
- 3. Domestic Water Systems:
 - > All water systems are operating without restrictions.
 - Performed quarterly blow-off valve exercising.
 - > Performed Air Relief Valve exercising.
 - WUD has continued to test all backflow devices in accordance with our Cross Connection Control Policy.
 - Conducted inspections of all well head seals and continuing to replace them as needed.
- 4. On-Call Activities:
 - There are zero calls to report.
- 5. Knights Ferry Pumping Station:
 - The Knights Ferry Pumps are activated. The river pumps are providing water to the treatment plant.
- 6. Irrigation Pumping Stations:
 - WUD had been de-activating the Ag pumps for winter.
 - WUD will continue to perform inspections on all winter drain pumps that are in operation for the winter.

Finance Activities

- 1. Health Insurance Open Enrollment employee meetings were held on Friday, November 4, 2016. To date 14 out of 66 participants are moving to Sutter Health.
- 2. Finance Meeting was held on November 7, 2016 to review the draft 2017 budget. The committee made a couple of recommendations but otherwise approved the budget.
- 3. Assisting GM in OE3 labor negotiations.
- 4. The final volumetric billing for the 2016 irrigation season was mailed out on November 10th. The total revenue generated for the 8/1-10/31/16 period for Tier 1 customers was \$384,482, Tier 2 customers was \$238,572, and out-of-district customers was \$20,419.

5. 6.	The Flexible Spending Account program's open enrollment period will be December 1. 2016 – December 31, 2016. Five Rejection of Claim and Settlement notices regarding On-Farm Conservation Program claims for damages were mailed out on November 9, 2016. ACWA JPIA has notified the District that this is not covered under the District's insurance.
